## **NEW LEASES**

ENSURE THE FOLLOWING ARE ACCURATE TO ALLOW FOR TIMELY PAYMENT PROCESSING.



- **1. LEASE:** A copy of the fully executed lease must be submitted to our office.
- 2. LEASE START DATE: The lease start date MUST be at LEAST 24 hours after the unit passes inspection.
- 3. LEASE END DATE: The lease end date MUST be the <u>last day of</u> the month prior to the initial month of move-in for the following year.
- **4. UTILITY RESPONSIBILITY:** The lease must indicate which party is responsible for paying each of the utilities at the unit.
- 5. PROOF OF UTILITIES: The tenant must show proof the utilities he/she is responsible for paying have been transferring into his/her name by providing the new account number(s) to CHA.
- 6. HAP CONTRACT: Sign and return a copy of the executed HAP Contract within 10 days of receipt.
